## NEW TRANSACTION MANDATE WITH CORPORATE ADVISOR

Manalto Limited (ASX:MTL) (**Manalto** or the **Company**) is pleased to announce that it has entered into a new corporate advisory mandate with EverBlu Capital Pty Ltd (**EverBlu**).
